HENRY COUNTY PUBLIC LIBRARY SPECIAL CALLED BOARD MEETING MINUTES AUGUST 30, 2018 2 p.m.

The meeting was called to order at 2:03 p.m. by Vice-President Dianne Brammell. The meeting was held in the meeting room of the henry County Library.

Public Comment: None

Minutes Reviewed: A motion to approve the Minutes of the July 28, 2018 board meeting was made by Tom Shroyer and seconded by Terry Johnson. The motion to approve the minutes was 4-0.

Circulation Report: The Circulation Report was reviewed and accepted.

Financial Reports, including approval of disbursements: After a review of the Financial Reports, a motion was made by Karen Fisher to accept the reports and approval of disbursements. A second was made by Terry Johnson and all members voted to approve the motion.

Director's Report: The transition to SirsiDynix' Symphony ILS is going well and staff will receive training on the circulation portion of the system on 9/6/18.

New Business:

- 1. Studio Kremer presented the updated bids received on 8/27/18 and made a recommendation to approve the bid packages pending the contractor vetting process. They also recommended raising the contingency from 5% to 6.5% due to possible unforeseen expenses in bid packages #9D and #11. A motion to approve bid packages #1-14 and raise the contingency from 5.0% to 6.5% was made by Terry Johnson and seconded by Karen Fisher. Vote 4-0.
- 2. Ruben Hayes' representative, Christian Juckett, recommended that the board adopt the resolutions related to compliance with IRS regulation and securities commission rules. Tom Shroyer made a motion to adopt the Resolution Regarding IRS Regulations and the Resolution Regarding SEC Disclosure Rules regarding written procedures to comply with the library's disclosure obligations related to tax-exempt bonds. The motion was seconded by Terry Johnson. Vote 4-0. These resolutions are attached to the minutes.
