Minutes Reviewed: A motion to approve the December 19, 2019 Minutes was made by Dianne Brammell and seconded by Tom Shroyer. The motion to approve was 4 to 0.

Circulation Report: the Circulation Report was accepted as presented.

Financial Report; including approval of disbursements: Following a review of the Financial Report, a motion was made by Terry Johnson to accept the report and approve the disbursements. A second was made by Dianne Brammell and all members voted 5 to 0 to approve the motion.

Old Business: Construction Project

- On January 23, 2020 state building inspector came to approve the building for occupancy.
- As of 1-17-2020 the balance to finish the construction project plus the retainage is \$339,408.51.
- Contingency Fund to date is \$70, 296.72 (76% spent and 24% remaining)
- A site drain will need to be regraded.
- Leak in collecting tank for the geothermal system causing the sump pump to kick on every 3-4 minutes. It will need to be patched (repaired). Will check to see if the work is under warranty. Waiting for more information from the manufacturer.
- Landscaper will come back to the site and replaced patches of dead sod.
- Some of the Eastern Red Cedars and Magnolia trees do not meet minimum height requirements. They will be replaced with correctly sized trees or will give \$50.00 back on each tree.
- Everything is moving along on schedule only a few items need attention (ex. Door hardware).

Incorrect Benchmark: No new information provided by the attorney.

Memorial Plaque: Presbyterian Church of Eminence, KY would like to donate memorials in memory of Eileen and Jim Prewitt and Martha Terry Simpson to the new library. A motion was made by Dianne Brammell to accept the memorial donation of \$1,000 or more
