#### I. Introduction

#### A. Henry County Public Library

Henry County was the first Kentucky county to vote for a library tax in order to finance the construction and maintenance of a county library. That vote resulted in the creation of the Henry County library district and the Henry County Public Library ("HCPL"). The library district is a political subdivision of the state, subject to the Kentucky statutes authorizing and governing library districts. These statutes regulate the creation and operation of library districts, and address such matters as tax bills and tax collection, governance, issuance of revenue bonds, procedures for increasing or decreasing library tax levies, certification of library staff, the role of other local government entities and accountability to state government. For example, pursuant to these laws HCPL is governed by a board of trustees appointed by Henry County officials from a list of candidates approved by the Kentucky Department of Libraries and Archives, must submit annual reports to that Department, and must make its records and books of account available for inspection by the Auditor of Public Accounts.

HCPL offers a wide variety of books, e-books, audiobooks, DVDs and databases, as well as public computers with internet access and productivity software suites. It also offers a wide variety of educational programs for children and adults, and operates a bookmobile. There is great need for these free library services, as 20% of county residents live below the federal poverty line and per capita income in Henry County is lower than that for Kentucky as a whole. Henry County's per capita library book circulation, in contrast, exceeds the state's.

#### B. Friends of the Henry County Public Library, Inc.

Friends of the Henry County Public Library, Inc. ("Friends of the Library" or "the Friends"), a membership and volunteer service organization, was founded in 2011 to assist the library in meeting community needs and fulfilling its educational mission. As stated in the Friends' Articles of Incorporation, the organization's purposes are to foster public awareness and appreciation of the Henry County Public Library; to stimulate use of the Henry County Public Library's resources and services; to support and cooperate with the Henry County Public Library in developing library services, facilities and educational programs for the community; to assist the Henry County Public Library through fundraising endeavors and volunteer service; to encourage gifts, endowments and bequests to the Henry County Public Library; to foster public understanding and support

of the freedom to read as expressed in the American Library Association's Bill of Rights; and to engage in other charitable and educational activities consistent with the aforementioned purposes. Towards these ends, Friends of the Library engages or plans to engage in the following activities.

#### II. Activities

### A. Volunteer Service and Material Support for Henry County Public Library

Friends of the Library anticipates initiating volunteer service and material support to HCPL during the 2013-14 fiscal year. Board volunteers are engaged in continuing discussion with HCPL staff to identify library needs, explore how the Friends might help and plan accordingly. While planning remains ongoing, potential forms of volunteer support identified to date, to be provided by Friends members, include assisting at HCPL special events and educational programs; assisting with routine day-to-day library operational tasks in areas in which there may be staff shortages (e.g., re-shelving books); collaborating with HCPL to publish a monthly newsletter; and/or researching and preparing grant applications on behalf of HCPL. Potential forms of material support include donating to HCPL resources such as books, e-books, subscriptions or other library materials; donating piece of equipment for which HCPL lacks funds; donating supplies for HCPL educational programs; and/or donating incentive gifts or prizes for HCPL's youth summer reading program. The costs of material support will be funded by the fundraising and development activities discussed below.

Volunteer service and material support will further Friends of the Library's exempt purposes of assisting HCPL through fundraising endeavors and volunteer service; supporting and cooperating with HCPL in developing library services, facilities and educational programs for the community; stimulating the use of HCPL's resources and services; and fostering public awareness and appreciation of HCPL. Friends of the Library allocates approximately 25% of its time to this activity, not including the time required for the membership development needed to create a pool of volunteers (see membership development and outreach, below) and to generate funds for material support (see fundraising and development, below).

#### B. Membership Development and Outreach

Friends of the Library works on an ongoing basis to build a community of members to nurture and support the library. The organization holds periodic membership drives on-site at the library, during which Friends of the Library membership tables are set up to offer information about the group and invite people to join. Friends volunteers also attend various community events, such as the Henry County Fair, to solicit membership, and Friends meetings are advertised (at no cost) in the local newspaper. Library supporters may also join throughout the year by filling out a membership form and submitting it to the HCPL's staff liaison to the Friends, or mailing the same directly to Friends of the Library. Annual membership dues are \$5.00 for an individual, \$15.00 for a family and \$2.00 for students and seniors.

As additional outreach tools, in 2013 Friends of the Library will hold a contest for local students to design a logo for the organization, with a prize of \$100.00. Book bags with the Friends logo will be sold for a modest cost during membership drives and fundraising events (see fundraising and development, below). The logo contest and the appearance of the book bags throughout the community will raise awareness of both HCPL and the Friends.

Membership development and outreach activities are conducted by member volunteers, including board members, working on-site at the HCPL and from their homes, with the associated costs funded by membership dues. These activities serve to organize community support for HCPL, increase the library's visibility in the community and expand the network of individuals and families that can be mobilized to provide volunteer service (see above) and fundraising support (see below) for the library. They thereby further Friends of the Library's exempt purposes of fostering public awareness and appreciation of the library; stimulating the use of the library; and assisting the library through fundraising endeavors and volunteer service.

Friends of the Library allocates approximately 20% of its time to membership development and outreach.

#### C. Fundraising and Development

Resource development and fundraising on behalf of HCPL, including identifying new opportunities and strategies, is an ongoing, core function of the Friends' volunteer board and membership. Friends of the Library engages in fundraising and development

activities so that it may provide HCPL with the material support discussed above. To date, its primary fundraising vehicle has been the book/bake sale, the first of which was held in May 2012. Friends members, including board members, volunteer their time to plan, organize and carry out these sales, and donate the baked goods to be sold. Books offered for sale are primarily books that the library has removed from its collection, with a smaller portion donated by the general public.

Friends of the Library plans to expand its fundraising efforts beyond book/bake sales once it obtains recognition of 501(c)(3) status. It anticipates that with recognition of 501(c)(3) status, the organization will be able to obtain the in-kind donations, sponsorships and support necessary to hold larger fundraising events without incurring substantial costs. Fundraising events will be held in local venues and organized by Friends volunteers. Also planned is publication and sale of a book of recipes by local cooks, to be compiled and sold by volunteers. On a slightly different note, the board plans to develop a strategy for encouraging businesses and community members to make gifts, endowments and bequests directly to HCPL, and to collaborate with library staff to pursue foundation and government grants that may be awarded directly to HCPL.

By securing resources for HCPL, fundraising and development activities further the Friends exempt purposes of assisting the HCPL through fundraising endeavors and volunteer service, and supporting and cooperating with HCPL in developing library services, facilities and educational programs for the community. In addition, the publicity and community education attendant to book/bake sales, other fundraising events and the distribution/use of the planned recipe book further the Friends' exempt purposes of fostering public awareness of and appreciation for HCPL and stimulating use of its resources and services.

Friends of the Library allocates approximately 40% of its time to fundraising and development.

#### D. Organization and Administration

The board of directors meets regularly to take care of the business of building, running and maintaining the organization. The board conducts this activity on a volunteer basis, meeting in free space at the Henry County Public Library. Directors also work between meetings on a volunteer basis, from their homes, as needed to carry out organizational and administrative activities that cannot efficiently be accomplished within the framework of a board meeting. The purpose of these activities is to create,

The affairs of the Friends are managed by its own independent board of directors which, under the organization's bylaws, elects its own members. Pursuant to Article VI, Section 2 of the Friends of the Library bylaws, anyone who supports and subscribes to the purposes of Friends of the Library is eligible to serve. HCPL does not require of the Friends any financial reports or audits, nor has it given Friends of the Library any governmental power or authority.
