Circulation Report: The circulation Report was accepted as presented.

Old Business:

Construction Update:

- Wehr Constructors has been unable to get the geothermal company to contact them about repairing the vault. Wehr will give the company 48 hours to contact them or the money owed to them will go toward the needed repairs on the vault.
- Wehr may be able to seal the hole in the parking lot with different layers of material to correct the problem.

Closed Session:

A motion was made by Karen Fisher to go into closed session to discuss sale of property and litigation. Seconded by Terry Johnson. All voted in favor 4 to 0. Board went into closed session at 5:23 p.m. Board came out of closed session at 5:35 p.m.

A motion was made by Terry Johnson with second by Tom Shroyer to accept an offer from Eminence Independent Schools to purchase the old library property at 173 Eminence Terrace in Eminence. Condition of sale that a formal contract offer be signed by the Superintendent of Eminence Independent Schools, Board of Trustees President Thomas Minton, and Library Director Tony Jones. All voted in favor 4 to 0.
