New Business:

• Library Woods Project

Tony talked to Kyle Atchison about the wooded area behind the library. The quote provided was \$1,300 which will include using a skid steer and brush cutter to remove all shorter trees and brush and then turn it into mulch. He can begin work the week after Thanksgiving. The area can be reevaluated after this work to see if anything additional needs to be removed. Steve offered to come and assist and to spray afterwards in the spring.
